Dear Friends.

The past year was full of growth, challenges, planning and investment for the Child Protection Center. Fiscal Year 2018 (July 1, 2017 through June 30, 2018) brought tremendous growth in services, especially in South Sarasota County with a 44% increase over the previous year. Most of this growth is in the North Port area. CPC has been **challenged** to meet the local demand for services. Our current staffing levels and limitations of our facilities has created a waiting list for services in this area. The leadership of our Board of Directors has begun planning to meet these challenges and strategically increase our capacity.

Last year, we felt the impacts of Hurricane Irma which caused some damage to our Sarasota, Venice and North Port locations, as well as an interruption of services for a 3 to 4-week period and slow return to full capacity. Because of this experience, we committed to training our staff and developing updated Emergency Operations and Continuity of Service Plans. We practiced fire drills and violent intruder drills to make sure we are prepared for things we hope never happen. Through this process we forced ourselves to think outside of the box and to be prepared.

We invested heavily in training for our therapy team as they completed 274 hours of training in Eye Movement Desensitization and Reprocessing (EMDR), Alternatives for Families -Cognitive Behavioral Therapy (AFCBT) and Trauma Focused Cognitive Behavioral Therapy (TFCBT). These trainings enhance our therapeutic interventions to help children and families impacted by the traumas of child abuse. Our employees are our greatest resource. We have chosen to invest in their learning to improve their skills and communicate that they are vital to our mission and organization.

To our community, there is nothing more important than our stewardship of your relationship with CPC. We want to demonstrate that we have the knowledge, skills and programs to make a difference in the lives of children and we are honored that you have partnered with CPC to help us achieve our mission and vision. We thank you for your support and continued partnership with CPC, we simply could not do what we do without YOU!

PRevention

Personal Safety & Community Awareness Program

The Personal Safety and Community Awareness Program (PSCA) offers a comprehensive approach to the prevention of child abuse through education and community awareness. PSCA provides education workshops to children from preschool through high school covering topics such as the touching rule, abduction prevention, internet safety and bullying prevention.

The program also facilitates workshops for caregivers, childcare professionals, teachers, school board staff and the greater community. Additionally, the program focus is the creation of a future in which children are empowered and educated, adults are aware and equipped, and our community is a safer place for children and families.



TReatment

Child Protection Center Therapy Program

The CPC Therapy Program provides specialized therapy for child victims who have made an abuse disclosure of physical and/or sexual abuse and children experiencing problematic sexual behaviors. This program is a Department of Health endorsed program requiring specialized therapy treatment through evidenced based interventions to provide effective treatment for the trauma of child abuse from a multidisciplinary perspective. The goal of CPC's Therapy Program is to resolve the trauma of physical and sexual abuse experienced by children, restore

healthy development, reduce child-on-child sexual abuse and rebuild relationships between children and their non-offending caregivers and siblings.

We believe in speaking to children and adolescents through many "languages" including art, music, writing, therapeutic games and cognitive processing. By utilizing unique therapeutic toys and child friendly interventions children are better able to express themselves to therapists while participating in purposeful therapeutic interactions.

Intervention

Child Protection Team

The Child Protection Team provides **expertise** in **evaluating allegations of abuse and neglect,** assessing risk factors, and providing recommendations for interventions to protect children. Child abuse and neglect involve complex issues and necessitate a multidisciplinary approach. This medically directed program includes services such as forensic medical assessments, forensic interviews, social history **evaluations**, and **community service referrals**.

Children & Families Supervised Visitation Program

When families are separated and going through a difficult time it is important that their children have a safe place to continue their relationship with their non-resident parent. The Children and Families Supervised Visitation Program (CFSVP) provides supervised visitation in a safe and private, child friendly environment at the center, under the supervision of a trained volunteer. The staff and volunteers are neutral to each family's situation, to ensure children are not placed in the middle of parental conflicts which helps children feel safe and protected. Supervised Visitation may be appropriate in many situations when there is a history of domestic violence, abuse, neglect, mental illness, and substance misuse. Families may also utilize services when the parent and child have been separated for an extended period of time and needs to be reacquainted, or their parents are going through a high conflict separation. CFSVP is the safest environment for children and families because it decreases the risk of children being emotionally or physically harmed when parents are in a high conflict situation or their non-resident parent exhibits unsafe behaviors.


Together we make a Difference









Revenues By source




